#### c. Patriot Disposal Letter.

Patriot Disposal sent a letter to Arrowood HOA providing us a temporary two plan option regarding that would require a \$5 temporary rate increase due to Gas Increases until the gas goes back down to \$2.49/Gal.

Option 1: If the association wanted to continue the two per week Trash Pickup the \$5 increase will be incurred making \$25/Household.

Option 2: Go to 1 day per week pickup and stay at the current rate of \$20 per household.

The Board will not allow our service to be reduced. We will accept the \$5 temporary increase. In the meantime we will request new quotes from other Trash disposal companies.

Haley from Sequoia will look into the contract to confirm that there should be a 90-day clause notice of any rate changes and will address that with Patriot.

We will allow this and will need to readdress/update the Architectural guidelines.
